The meeting was called to order by Board President Steve Riback at 7:00 p.m.

APPROVAL OF MINUTES

A motion was made by Mr. Riback and seconded by Mr. Chiarella to approve the minutes for the Public Board of Education Meeting, March 18, 2020. Motion carried with Ms. Arminio abstaining.

PRESENTATIONS:

NJ STUDENT LEARNING ASSESSMENT – SCIENCE RESULTS

Dr. Layman presented the results of the New Jersey Student Learning Assessment (NJSLA) for Spring 2019. Dr. Layman explained that New Jersey transitioned from the PARCC Assessment to the NJSLA and students in grades 5, 8 and 11 are required to participate in the science assessment. The presentation included the district's performance compared to the state levels. Dr. Layman reported that staff will continue to research test taking strategies to further provide the students with the skills that will allow for success.

REFERENDUM PRESENTATION AND PUBLIC HEARING

Dr. Alvich provided a slide presentation with options for a future referendum. Dr. Alvich stated that the goal was for a December referendum. Dr. Alvich provided a description of each the Plans (A-C) which included pros and cons, timeline, enrollment capacity and costs for each plan. Dr. Alvich stated that it is administration's recommendation that if the Board wants to move forward with a December referendum, they go with Plan B, as it meets the needs for the near future. Dr. Alvich added that considering the economic situation that we are in right now and with the unknowns with COVID-19, her recommendation is to postpone the referendum. Dr. Alvich reported that if the Board decides to proceed with a December referendum, a plan will have to be selected this evening to meet the requirement deadlines.

Mr. Chiarella stated that if the Board agrees to postpone the referendum, they may need to consider a contingency plan, such as adding trailers to alleviate some pressure to abide by the guidelines for social distancing. Dr. Alvich added that considering all the uncertainty, especially the state funding for the fall, the District cannot add trailers for this September.

Mr. Tufano thanked administration for getting the plan costs so quickly but expressed concern regarding the accuracy of the figures. Mr. Tufano suggested holding off providing the public with the costs until we have accurate numbers.

Ms. Arminio inquired about the type of and location of the modular units listed in Plan A. Ms. Arminio stated that the District needs to request that architects not be confined to stick building because that is where the highest costs are. Ms. Arminio suggested that going forward the Board makes sure that when they request designs, they can accommodate different scenarios. Dr. Alvich added that when they spoke with Epic, they requested the cheapest option for each of those types of construction.

Ms. DeMaio inquired about the serious needs at Applegarth School and the possible costs that the District is looking at. Dr. Alvich stated that she was referring to a possible problem with the boiler, which is approximately 84 years old or roof replacement. Dr. Alvich indicated that the Board may not want to put a million dollars into a building they may choose to replace. Dr. Alvich added that the District has insurance, emergency funds and contingency plans in place should it be needed.

Mr. Nikitinsky inquired about the cost just for Applegarth School in Plan B and the costs to replace or repair the roof or boiler. Mr. Nikitinsky stated that he would prefer to spend five million on a boiler and roof than a hundred million to build a school right now, and suggested that the Board look into ways to repair and extend the school rather than construct a new one. Mr. Gorski added that previous discussions with architects and engineers suggested that it would be less expensive to build a new school than a restoration of all the existing structures. Mr. Gorski added that many of the systems within the school are well beyond there useful life.

Mr. Paluri added that Epic is a construction management company they do not construct the building themselves. Mr. Gorski confirmed that they are cost engineers and site managers.

Mr. Riback inquired if a plan must be picked this evening and if one is picked this evening if the Board can adjust that plan. Ms. Arminio stated that if the Board chooses to postpone the referendum, she hopes that it is only postponed to the next available date and that the discussions and planning continue. Dr. Alvich added that given the current economic situation and the possible delay in construction, the District may not see the projected numbers stated in the demographer report.

Board President Riback announced that any members of the public may offer comments at this time.

PUBLIC FORUM ON REFERENDUM

Krishna Tekale 11 Jake Place – spoke regarding the demographic report versus actual student enrollment and the numbers used when creating the plan options. Mr. Tekale suggested that the Board seek permission from the DoE to keep some classes virtual to create space.

Michael O'Lesky 50 Mayberry Avenue – stated that he supports Plan B and the decision to put it on hold and further develop it. Mr. O'Lesky inquired about the traffic study near the golf site.

Pradeep Melam 4 Jake Place – spoke about the costs shown in the referendum plans and stated that they are very costly and do not show a breakup of what the details are. Mr. Melam inquired if Jamesburg will be absorbing 3% of the project cost because 3% of high school students are from Jamesburg. Mr. Melam also inquired why the Jamesburg Representative has a voting right in the referendum plan.

Ram Ranganath 6 Owens Drive – Spoke regarding the referendum plans and stated more details and figures should have been shown for the higher end items. Mr. Ranganath questioned the costs provided by Epic. Dr. Alvich stated that she would post the breakdown of costs of the plans on the district website.

Gurpreet Singh 15 Belmont Court – asked the Board to consider the plan that they think the residents will approve in a referendum.

Gazella Borha 1 Miko Drive – spoke about the demographer's report and questioned if the numbers add up, as she does not believe there will be more construction in the upcoming years than in prior years. Ms. Borha stated that she supports Plan B as it is more economical and agrees that the Board should hold off on picking a plan right now as the world we know has changed.

Chrissy Skurbe 21 Preakness Drive – stated that she supports postponing the referendum. Ms. Skurbe further stated that she recalled that the Board was asked to present plans with two price tags for each plan, one with brick and mortar and the second with modular.

Sarah Aziz 3 Launcelot Drive – suggested that the Board support Plan A, as she believes it is the most fiscally conservative option. Ms. Aziz stated that her research shows that no district in New Jersey has been able to alleviate 2,000 unhoused students without building a brick and mortar school.

Prakash Parab 33 Dayna Drive – spoke regarding the demographer's report and stated that the report was conducted prior to the pandemic so the numbers may not be accurate now. Mr. Parab

stated that he supports Plan B, but he would like to see a breakdown of costs and further research of modular companies.

Mr. Riback stated that since the members agreed to not select a plan or a date for the referendum, they would not be doing so this evening. Mr. Riback further stated that the Board will take the time to further develop a plan, schedule an extended bg&t committee meeting, and request more options with associated costs.

COMMITTEE REPORTS

Ms. Jill DeMaio, Chairperson of the Curriculum Committee, reported that the committee met earlier and reviewed the curriculum document for Instrumental Music Grades 7-8 and discussed the textbook Impact Social Studies from McGraw-Hill publishing for Grade 5. Ms. DeMaio further reported that the committee did not get to review the Unified Physical Education and Falcon P.A.L.S program.

Ms. Rupa Siegel, Chairperson of the Policy Committee, updated the Board on the revisions to Bylaw 0145/Board Member Resignation and Removal and Policy and Regulation 5330/Administration of Medication. Ms. Siegel shared a communication from New Jersey School Boards Association (NJSBA) regarding the Board/Superintendent Relationship.

Regarding Bylaw 0145, Ms. Arminio inquired if the number of meetings missed is for all meetings including committee meetings or specifically board of education. Mr. Gorski clarified that it is for three consecutive board of education meetings.

Mr. Andy Paluri, Chairperson of the Educational Advocacy Committee, reported that the committee did not meet this month but at the last meeting they decided that the committee should send a letter stating that they do not support bills S-2392/A3969.

A motion was made by Mr. Paluri and seconded by Mr. Chiarella that the members of the Monroe township Board of Education approve the following resolution by consent roll call:

WHEREAS, the Educational Advocacy Committee has stayed abreast of current legislative developments pertaining to school districts, specifically those affecting state aid and municipal tax revenue; and

WHEREAS, the current version of bills S-2392/A-3969, which allows municipalities to extend/delay the dates for the payment of taxes by a municipality to school districts, is currently pending in the legislature; and

WHEREAS, the state budget resources are in an uncertain state in view of the COVID-19 pandemic and the unclear Federal stimulus payments that may be provided to the state; and

WHEREAS, there is a concern that there may be a reduction in the state aid award notice to school districts.

NOW, THEREFORE, BE IT RESOLVED that the members of the Monroe Township Board of Education authorize and participate in a community letter writing campaign to lobby in

the interests of the school district and to vigorously oppose any proposed legislation that would jeopardize the revenue stream to the District.

Roll call 10-0-0-0 Motion carried.

Ms. Kathy Kolupanowich, Chairperson of the Personnel Committee, reported that the committee met last week and discussed the contracts for three administrators which are on the agenda for approval this evening. Dr. Alvich stated that Item U/ Board Attorney contract was pulled from the agenda this evening pending a legal opinion. Ms. Kolupanowich reported that the contracts for the Business Administrator and Assistant Superintendent of schools reflect a zero percent salary increase.

Mr. Paul Rutsky, Chairperson of the Finance Committee, reported the committee reviewed the Falcon Care/ECE interim financials. Mr. Rutsky reported that due to the COVID-19 closure the programs may see approximately \$200,000.00 less of a profit than last year.

Mr. Rutsky reported that the committee discussed the Extraordinary Aid and Mr. Gorski reported that the District will receive \$504,000.00 in Extraordinary Aid for 29 students in the 18/19 school year.

Mr. Rutsky stated that the committee discussed temporary borrowing options available to the Board should state aid be held or cut.

PUBLIC FORUM-

Piyush Patel 51 Violet Court – spoke about the student capacity at the high school and suggested that the number of classes held there be significant to pass any referendum.

Pradeep Melam 4 Jake Place – stated that his comments earlier regarding the Jamesburg Representative were not made in a negative manner towards Mr. Rutsky. Mr. Melam stated that his issue is that the Jamesburg representative voted on items that have nothing to do with Jamesburg.

Gazala Bohra 1 Miko Drive – spoke regarding the business administrator's contract and inquired if there is a resolution from the pending ethics violation against him. Ms. Bohra inquired if all the board members are aware of that complaint.

Chrissy Skurbe 21 Preakness Drive – spoke regarding the business administrator's contract and the increase in fees that are being passed on to the community.

Michael O'Lesky 50 Mayberry Avenue – spoke regarding the repairs needed at Applegarth School and suggested a report be issued so the residents can be made aware of those needs.

ASSISTANT SUPERINTENDENT REPORT

Dr. Layman stated that he reached out to Dr. Higgins and the senior class advisors regarding the Board's offer to purchase a plaque for the class of 2020 and to collect feedback to see if there was something that they felt the students would appreciate more. Next, Dr. Layman highlighted some of the professional development opportunities that are being offered during remote

learning. Most of the courses run multiple sessions to allow for any staff member that has an interest/need in pursuing this information to have that opportunity. Dr. Layman stated that the technology staff, staff developers, and teacher trainers have done an amazing job facilitating these opportunities. This support has allowed our staff to develop the tools to be successful in a remote environment as well as move forward with preparing staff for the 2020-21 school year.

SUPERINTENDENT'S REPORT

Dr. Alvich acknowledged and congratulated Ms. Susan Green-Nowachek, Mr. Theodore Powoski, and Ms. Robin Silverman on their retirement and thanked them for their service to the District. Dr. Alvich stated that unfortunately the June meeting will be virtual so staff that retired this year will not be recognized at the June meeting. Dr. Alvich stated that she hopes they can be recognized at a future meeting with the Teacher and Educational Support Staff of the Year recipients.

PERSONNEL

A motion was made by Mr. Rutsky and seconded by Ms. Kolupanowich that Personnel Items A - X with the exception of Item U be approved by consent roll call. Mr. Nikitinsky reported that the personnel committee was not informed about any ethics violations with the business administrator and required that the item be tabled and discussed in closed session.

A motion was made by Mr. Nikitinsky and seconded by Ms. Arminio to table Item S until further discussion can be held. Roll call 3-6-0-1-0. Motion failed with Ms. DeMaio, Ms. Kolupanowich, Mr. Paluri, Mr. Rutsky and Mr. Riback voting no and Mr. Chiarella recusing.

Roll Call for Superintendent's Personnel Report 10-0-0-0. Motion Carried with Ms. Arminio, Mr. Nikitinsky and Mr. Tufano voting no and Mr. Chiarella recusing on Item S. The vote included the Jamesburg Board Member Representative where appropriate. A copy of the Superintendent's Personnel Report is attached to the official set of minutes.

BOARD ACTION

A motion was made by Mr. Riback and seconded by Mr. Paluri that Board Action Items (A - P) be approved by consent roll call. Roll Call 10-0-0-0. Motion Carried with Ms. DeMaio and Ms. Siegel abstaining on Item M and Ms. Arminio abstaining on Items I, J, K, L and M and Mr. Nikitinsky recusing on Item L. The vote included the Jamesburg Board Member Representative where appropriate. A copy of the Superintendent's Report is attached to the official set of minutes.

BUSINESS ADMINISTRATOR'S REPORT/RECOMMENDATIONS

A motion was made by Mr. Chiarella and seconded by Ms. DeMaio that Board Action Items A-N be approved by consent roll call. Roll Call 10-0-0-0. Motion carried. The vote included the Jamesburg Representative where appropriate. A copy of the Board Action section of the Business Administrator's Report is attached to the official set of minutes.

BOARD PRESIDENT REPORT

Mr. Riback stated that Senator Sweeney was the guest speaker at the NJSBA Legislative Committee Meeting last week. Mr. Riback reported that Senator Sweeney informed them that it

will be impossible to predict what state funding will look like for next year at this time and not to anticipate any increase for next year. Senator Sweeney further stated that he will not support any bills that defer payment of tax payments to school districts and encourages residents to reach out to legislatures to oppose them as well.

OTHER BOARD OF EDUCATION BUSINESS

Mr. Rutsky acknowledged Dr. Layman's performance this past year. Mr. Rutsky also stated that it is very commendable that he and Mr. Gorski did not seek an increase in salary for next year. Mr. Paluri and Mr. Riback echoed Mr. Rutsky's statements.

PUBLIC FORUM

Chrissy Skurbe 21 Preakness Drive - stated that she thinks it is said that some board members do not care about pending ethics violations.

Prakash Parab 33 Dayna Drive - inquired what plan the Board selected and what date the referendum will be. Mr. Parab inquired how the highschool student enrollment growth will be addressed. Mr. Parab requested that the Board draft a letter for a writing campaign imposing impact fees to developers.

Lawrence Liu - stated that Mr. Gorski is doing a great job and the small town politicking and hating on him that is going on is detrimental to the well being of the town.

Betty Saborido 2 Barrymore Drive - commended Dr. Alvich for initiating the Behavior Analyst webppage on the district website and working so closely with SEPAG. Ms. Saborido also commended Dr. Layman for not seeking any increase in salary for next year.

CLOSED SESSION RESOLUTION

Dr. Alvich announced that the closed session agenda item has been postponed and the meeting will not take place this evening.

NEXT PUBLIC MEETING

Mr. Riback stated that the next public meeting of the Monroe Township Board of Education will convene at 7:00 p.m. on Wednesday, June 10, 2020.

ADJOURNMENT

A motion was made by Mr. Riback and seconded by Mr. Rutsky that the meeting be adjourned. Motion carried. The public meeting adjourned at 10:26 p.m.

Note 1: Any member of the public may record the proceedings of a public meeting of the Board in a manner that does not interrupt the proceedings, inhibit the conduct of the meeting, or distract Board Members or other observers present at the meeting.

The Board will permit the use of tape recorders, still or movie cameras, or videotape cameras only when notice of such intended use has been given to the Board Secretary one day in advance of the meeting. Any video recording device must be located and operated from inconspicuous locations in the meeting room as determined by the presiding officer of the meeting. The presiding officer may also limit the number of video recording devices if he/she determines the number and position of the video recording devices will be an unnecessary intrusion to the meeting. In this event, preference will be given based on the order in which prior notice requesting to record the meeting was provided to the Board Secretary.

The presiding officer shall determine when any recording device interferes with the conduct of a Board meeting and may order that an interfering device be removed.

Note 2: The Jamesburg Representative shall be eligible to vote on only those matters specifically designated in <u>N.J.S.A</u> 18A:38-8.1, as follows:

- (1) Tuition to be charged the sending district by the receiving district and the bill lists or contracts for the purchase, operation or maintenance of facilities, equipment and instructional materials to be used in the education of the pupils of the sending district.
- (2) New capital construction to be utilized by sending district pupils.
- (3) Appointment, transfer or removal of teaching staff members providing services to pupils of the sending district, including any teaching staff member who is a member of the receiving district's central administrative staff.
- (4) Addition or deletion of curricular and extracurricular programs involving pupils of the sending district.
- (5) Any matter directly involving sending district students or programs and services used by them.
- (6) The annual receiving district budget.
- (7) Any collectively-negotiated agreement involving employees who provide services used by sending district students.
- (8) Any individual employee contracts not covered by a collectively-negotiated agreement, if those employees provide or oversee programs or services utilized by sending district students.
- (9) Any matter concerning governance of the receiving district board of education, including, but not limited to, the selection of board president and vice-president, approval of board bylaws, and the employment of professionals or consultants such as attorneys, architects, engineers, or others who provide services to the receiving district board of education.

To the extent the Jamesburg Representative inadvertently votes on any other matter, his vote shall not be counted.

Note 3: Public discussion is confined to this portion of the Agenda unless permission is granted by the Board President prior to the start of the meeting or when the Board is considering a Special Agenda Item that the Board deems appropriate for public participation. Anyone wishing to address the Board is requested to stand and state his/her name and address.
