#### **PUBLIC FORUM**

Doug Poye, Monroe Township – congratulated the newly appointed members of the Board. Mr. Poye encouraged all members to be mindful and be non-partisan with their comments and votes. While the Budget is in the development stage, Mr. Poye requested that the Board explore the matter of courtesy busing. Mr. Poye stated that students who live under two miles and are not transported may encounter safety hazards that have been created by township development without the consideration of the school district. Mr. Poye reported that other Boards of Education have Agreements with their Townships to bear the costs of transporting their effected students.

Pradeep Melam, Monroe Township – congratulated the newly appointed board members and the Jamesburg Representative for this year. Regarding budget cuts and courtesy busing, Mr. Melam requested that if cuts are necessary, they be made throughout the district and not just in the Oak Tree School area. Mr. Melam requested that all board members put the kids and education matters first over their personal beliefs and political affiliation. Regarding Board Goals, Mr. Melam suggested that the Board simplify their Goals and state what they are going to do about the referendum and state funding in the first six months. Lastly, Mr. Melam suggested that when forming committees, a liaison be assigned to work with township and state officials that could help with state funding.

Michele Arminio, Monroe Township – thanked the community and follow board members for their support over the nine years that she was a member of the Board of Education. Ms. Arminio expressed that over the last few months that she was on the Board, not all of the board members were duly informed of all of the information that was available to them. Ms. Arminio requested that in the future all members are provided information equally. Ms. Arminio wished the new Board well and requested that they make their decisions based on student achievement, student health and welfare, and the welfare of the community.

Patrice Faraone, Monroe Township – expressed concern that the former Jamesburg Representative was not on any committees and with that in mind, Ms. Faraone inquired how the new Representative could support Ms. Skurbe for Board President.

#### **ORGANIZATIONAL ITEMS**

A motion was made by Ms. Belko and seconded by Ms. Rattner that the members of the Board of Education accept and approve Organizational Items A-D by consent roll call.

Regarding the start time for Item A/Meeting Date Schedule, Ms. Scott suggested that the Board consider starting closed session meetings at 6:00 p.m. and if needed hold another closed session later in the agenda. Ms. Belko stated that due to her work schedule she would be in favor if it, if the start time was 6:30 p.m. or 6:45 p.m.

Mr. Tufano stated that he feels that a large portion of the public meeting is spent on committee reports. Mr. Tufano inquired if the notes from those meetings could be placed on the agenda or website to eliminate the time spent providing a report, especially that the committee meetings are recorded for the benefit of the public. Ms. Skurbe suggested that committee reports remain on the agenda but are kept to a brief update in case a board member has a question prior to a vote.

A point of order was made by Ms. Belko as a motion was on the floor.

Ms. Rattner made a friendly amendment which was seconded by Ms. DiPane to the motion on the floor to amend the meeting start time in Item A/ Meeting Date Schedule to 6:30 p.m. Ms. Belko who second the motion on the floor could not except the amendment to the motion due to conflict with her work schedule. Both Ms. Rattner and Ms. DiPane withdrew their amendment.

Ms. Fabiano made a motion which was seconded by Ms. Bohra to move the start time of Board of Education Meetings to 6:30 p.m. to allow the board to go into closed session for a thirty-minute executive session and return to the public portion of the meeting at 7:00 p.m. Concerns were raised regarding the length of time that is wasted going to and from the closed meeting and how much would actually be accomplished within the thirty minutes. Ms. Belko called a point of order stated that the logistics could be worked out at another time.

Ms. Fabiano and Ms. Bohra agreed to amend their motion to have the closed session begin at 6:30 p.m. and members return to the public portion of the meeting at 7:15 p.m. Roll Call 9-1-0-0-0 motion carried with Ms. Belko voting no.

Ms. Skurbe stated that she would reach out to the districts' new representative at NJSBA.

Ms. Bohra welcomed the newly elected members to the Board and the members of the public that are in attendance this evening. Ms. Bohra stated that it is an important year with the referendum and public feedback through public participation will be appreciated. Ms. Belko, Ms. Fabiano, Ms. Scott and Ms. Skurbe echoed Ms. Bohra's comments.

Ms. Skurbe announced that there may be a need for a special meeting next Thursday, January 12<sup>th</sup> regarding a resolution that would have to be voted on for the referendum.

Ms. Skurbe stated that the next public meeting of the Monroe Township Board of Education will convene at 6:30 p.m. on Wednesday, January 25, 2023.

Ms. Skurbe requested that members take a Committee Preference Sheet and return to them to her. Ms. Skurbe added that after the committees are formed, a Committee Member List and Schedule will be sent out.

**Note 2**: The Jamesburg Representative shall be eligible to vote on only those matters specifically designated in N.J.S.A 18A:38-8.1, as follows:

- (1) Tuition to be charged the sending district by the receiving district and the bill lists or contracts for the purchase, operation or maintenance of facilities, equipment and instructional materials to be used in the education of the pupils of the sending district.
- (2) New capital construction to be utilized by sending district pupils.
- (3) Appointment, transfer or removal of teaching staff members providing services to pupils of the sending district, including any teaching staff member who is a member of the receiving district's central administrative staff.
- (4) Addition or deletion of curricular and extracurricular programs involving pupils of the sending district.
- (5) Any matter directly involving sending district students or programs and services used by them.
- (6) The annual receiving district budget.
- (7) Any collectively-negotiated agreement involving employees who provide services used by sending district students.
- (8) Any individual employee contracts not covered by a collectively-negotiated agreement, if those employees provide or oversee programs or services utilized by sending district students.
- (9) Any matter concerning governance of the receiving district board of education, including, but not limited to, the selection of board president and vice-president, approval of board bylaws, and the employment of professionals or consultants such as attorneys, architects, engineers, or others who provide services to the receiving district board of education.

To the extent the Jamesburg Representative inadvertently votes on any other matter, his vote shall not be counted.

**Note 3**: Public discussion is confined to this portion of the Agenda unless permission is granted by the Board President prior to the start of the meeting or when the Board is considering a Special Agenda Item that the Board deems appropriate for public participation.
